

Babel Chat Terms of Use

Welcome to Babel Chat. These Terms of Use ("Terms") govern your access to and use of Babel Chat's services, including our website, email communication services, AI bots, and any other services we provide (collectively, the "Service"). "Babel Chat," "we," "us," and "our" refer to the Babel Chat service and its affiliates.

By accessing or using the Service, you agree to be bound by these Terms and our Privacy Policy. If you do not agree to these Terms, please do not use the Service.

1. Eligibility

You must be at least 13 years old to use the Service. By agreeing to these Terms, you represent and warrant that you are of legal age to form a binding contract with Babel Chat and meet all of the foregoing eligibility requirements.

2. Use of the Service

Babel Chat grants you a limited, non-exclusive, non-transferable, and revocable license to use the Service subject to the restrictions set forth in these Terms.

You agree not to use the Service in any way that:

- Violates any applicable national, federal, state, local, or international law or regulation.

- Promote any illegal activity, or advocate, promote, or assist any unlawful act.

The Service and its original content, features, and functionality are and will remain the exclusive property of Babel Chat and its licensors. The Service is protected by copyright, trademark, and other laws of both the United States and foreign countries.

5. Termination

We may terminate or suspend your access to the Service immediately, without prior notice or liability, for any reason whatsoever, including without limitation if you breach the Terms.
